



April Late Stay Process

On March 8th students living on campus received information regarding a late stay requests process. While the majority of students will participate in remote learning after April 10th for the remainder of the semester, we recognize the need for some students to remain on campus to participate in on campus academic activities. Students were able to submit a request for a late stay by submitting an online request form and additional information on their reasons for needing to stay on campus, and are being notified on a rolling basis if they are eligible to stay past April 11th.

This request process closed on March 26th but if circumstances change after this date, students can make individual requests with Residential Life by emailing livingoncampus@uconn.edu. Information about this process and eligibility is available on our website at https://reslife.uconn.edu/late-stay-request-process/. Our goal is to have limited students on campus after April 11th so that we can finish the semester as healthy and safe as possible. University staff will begin to do an extensive cleaning of campus during the late spring and summer months to prepare for fall and to ensure that we can accommodate any students remaining on campus during the summer.

Any student living on campus that did not request a late stay has a move out date of April 11th. Students received specific information about how to move out and what the procedures are to check out and return keys. Parents and families also received an email reminder from Residential Life about the move out date and how to support students during the move out process.

Thank you for your continued support of your student this semester! We are pleased that we were able to maintain another healthy and safe semester on campus for our students, and this was made possible by your student's commitment to UConn and to staying safe. We are all looking forward to a fall semester that looks to have more in person learning, activities, and residential capacity. We will send more information during the summer months as it becomes available for us to share with you!

Summer Housing On-Campus

This year, Summer Housing officially begins Tuesday, May 10, 2021. Due to COVID-19 safety constraints, summer housing on campus will be limited to students who are otherwise unable to return home and those who do not have another place to live for the summer term. This does not include students who need a local place to live because they are completing an internship or working on or near campus. Students who are taking online-only courses, working on campus, or completing an internship are not eligible for summer housing this year.

Summer residents should plan to live in single-occupancy spaces in Werth Tower. A meal plan is also required for any residents living in Werth. Both housing and dining are billed on a weekly flat rate (Sunday-Saturday). Information about costs can be found on our website: https://reslife.uconn.edu/summer-housing/ Our Temporary Health and Safety Procedures will remain in place for summer term and residents should anticipate periodic test and the possibility of quarantining/isolating, similar to the Fall and Spring semester.

While the priority deadline for the Summer Housing Application was due March 26, students who determine they need summer housing after this date can contact our office at Livingoncampus@uconn.edu to request access to the Summer Housing Application.

General Housing Selection Email to Students

The following message was sent on March 31, 2021 to students eligible to be in General Room Selection

March 31, 2021

Dear student,

We are writing to you as a student eligible to live on campus for fall 2021, with some updates about the upcoming housing selection process and information pertaining to the weekly Dean's email that was sent earlier.

The email indicated that we will need to set aside spaces for quarantine and isolation purposes for the fall semester, to appropriately accommodate students who are not vaccinated when we return in the fall, or who may test positive for COVID during the fall semester and may need medical care. The hope is that as the summer progresses and more students are vaccinated, we will not need the full number of beds that were initially set aside. However, for planning purposes at this time, the spaces we need to set aside will not be available in housing selection and will not be available for students to choose as their fall housing assignment.

It is necessary to set aside apartment style and suite style spaces for quarantine and isolation. This impacts the selection process and there will be several areas missing from selection, including Charter Oak Apartments, Busby Suites, Northwood Apartments and some buildings in Hilltop Apartments and South Campus. We know that these are highly desirable spaces for juniors and seniors. As the Dean's email mentioned, the hope is that over the summer some of these spaces can be made available for student assignments and that they can be offered to junior and senior students via an online room change process. In order for junior and senior students to be eligible for a room change process in the summer they must select an available space during the April selection process students who do not select a space during he April process will not be eligible for a room change in the summer.

We are moving forward with plans for fall 2021 to be at an increased housing capacity, and we hope that you continue with your plans to live on campus. As the spring and summer months progress, we will make necessary adjustments based on the health and status of the state. We will always have your best interests in mind and will communicate updates to you as early as possible.

As information becomes available about a possible room change process in the summer for upper division students, we will send an email with instructions on who is eligible to apply and how to participate.
