Why is Residential Life changing the guest policy for the spring semester?

We have learned during the fall semester that the spread of COVID-19 on campus is because of small interactions such as card games, common meals, and other informal interactions during which students are not practicing physical distancing and mask wearing. This fall, in an effort to provide students with the opportunity to interact and fulfill their need to socialize, we have encouraged them to engage in activities that can take place outside. As the weather turns colder it will become increasingly more difficult for students to do this.

We know that hosting guests (non "family unit" members) in small residence hall rooms or apartments doesn't really support physical distancing which is a precaution that helps to reduce the spread of infection, and so we made the decision to not allow guests in these spaces. After speaking with some students, parents, and other staff at the University we slightly modified the no guest policy to allow residential students to spend time with one another in the common areas of the residence halls, meaning lounges and area community rooms. We know how important it is for students to engage with one another socially and we are hopeful that this change will allow for this interaction in a safe way.

Residential Life staff always strive to meet the needs of students and to listen to feedback. Changing this one piece of the Temporary Health and Safety Procedures document is an example of us trying to balance the need to socialize and the need to keep ourselves and others safe.

Spring 2021 Housing Information

On October 2nd your student received an email from our department with information regarding spring semester housing. The ongoing COVID-19 pandemic will not allow the residential areas to be open at full capacity as hoped for spring 2021. As such, we will need to continue under a similar reduced occupancy model of around 50% occupancy.

We have asked all students to indicate their interest in living on campus for spring to apply, regardless of fall housing status. This will allow us to appropriately plan for any students who may want to return home or make other housing plans, as well as plan for students who wish to return to campus and for other students who may be interested in joining the on campus environment for spring.

Students have access to this form in their MyHousing account, under Applications. It may be helpful for you to discuss your student's plans and expectations with them for the upcoming semester and to review the email they received. There is a copy of the email sent to students and a FAQ section about spring housing on our website, under the header "Residential Life Covid-19".







Additionally, students who currently live on campus received an email regarding housing information for Winter Recess, if they have a need to remain on campus from November 21-January 18. Information about Winter Recess housing can be found on our website at https://reslife.uconn.edu/winter-break-housing/.

Students who currently live on campus and are approved to return for spring will have the option of leaving their belongings in their room, if they choose to return to the same assignment. Any other student changing rooms or leaving campus permanently will need to move all their belongings out by November 21.



- Busby Seminar Room 126 (for residents in Bubsy Suites, Charter Oak & Northwood)
- Shippee Pequot Room on ground level (for residents of Shippee, Buckley, & East)




Fall Semester Closing & Spring Opening Sneak Preview!

In just under a month the Residence Halls will be closing as students have the remainder of their semester online. Saturday, November 21st the Halls will close at 5pm and students will have to leave. Those that have applied for and been granted housing for the spring 2021 semester may be able to return to their same room and thus may leave some belongings in the space.
