Process for Campus Change students

Living On-Campus At Storrs

- 63%, approximately 12,000 undergrad students live on campus
- Up to 40,000 people on campus each day-faculty, staff, students, etc.
- High demand for housing, excellent community environment on campus







Occupancy

- Due to the high demand for housing, we are planning for a typical, full occupancy academic year
- If the University decides to make changes to these plans that impact housing or housing occupancy, students will be informed at the time those decisions are made



Important Tips



- Work on your approval documentation early. Don't wait until the last minute!
- Your deadline for your approval and housing application is on our website under "Important Dates" (<u>reslife.uconn.edu</u>)
- Complete the appropriate housing application in your MyHousing portal.
- Expect to have a roommate. Plan how to share space with another student and to negotiate roommate conflicts or concerns.

DON'T miss it!

- Read email. Pay attention to detail and deadlines.
- Deadlines are not guidelines!

- Meet other students.




How you are assigned to a space

- In most cases, students select their own rooms.
- Qualified campus change student participate in room selection. To qualify for the selection process,

Campus Change students must:

- Meet all deadlines and requirements
- Be guaranteed housing
- A timeline and information about room selection is on our website.
- Campus Change students who don't meet the deadlines or who are not guaranteed housing are placed on the waitlist. These students are offered housing if we have space available.



A bit about room selection

- Selection times are generated based on class standing and credits earned. Students with the same amount of credits will select in random order.
- You can select a room beginning with your time and up until the end of the process. https://reslife.uconn.edu/living-on-campus/selecting_housing/
- You'll receive a selection time in that will be listed in your MyHousing portal.
- You can select housing with another campus change approved student or a Storrs student, as long as they are eligible and also participating in selection.
- Once you choose, you cannot change your selection, so don't rush and choose wisely!



Some things to consider when planning to select your room....

- It is important to have realistic expectations for your selection time.
- For traditional single rooms, a medical accommodation is required through the Center for Students with Disabilities.
- There are not enough apartment spaces for the entire senior class.
- The more roommates you are paired with, the tougher it will be to find a space. You can select with up to 5 roommates but as spaces are selected, there will be fewer options with 6 spaces available together.
- Consider multiple options for your selection. If you cannot find a suite for 6 of you together, how will you split your group? Or, if you cannot find a specific room number, think of other rooms you might be interested in.
- Consider location vs. roommates and what is more important to you; room type and location or the person you live with.

FAQs

- When is the deadline to have my campus change approved and/or application submitted?
 - March 1, 2024 is the deadline for both campus change approval and housing application submitted.
- Can I select housing with a current Storrs campus student?
 - Yes; if you are both eligible for selection you can match in the roommate selection process.
- Am I guaranteed housing if I have previously lived on the Storrs campus?
 - Students who have previously lived on-campus at Storrs are not guarenteed housing.
- What should I do if I require a medical accommodation?
 - Contact the Center for Students with Disabilities (CSD) to register for your medical needs.
- What if I require summer registration to be approved for Campus Change?
 - Summer registration dates are after the deadline for Campus Change & the Housing Application. We will work with students who require summer registration, if they are approved for Campus Change after registration, have completed their Housing Application by the March 1st deadline, and space is available.
- What if I decide to remain at my Regional Campus?
 - Students who cancel their campus change are not responsible for any cancellation fees.
